### MyGeni's Terms of Service

Welcome to Mygeni.org, the new generation in social networking where users can stay in touch with their friends, family and meet like minded people and effect change in the world around them ('Mygeni Service'). MyGeni.org is operated by MyGeni, Inc. ('MyGeni') and may be accessed through the Internet Mobile Internet and through WAP services provided by certain mobile network providers. By using the MyGeni Service you accept and agree to be bound by the following terms and conditions (the 'Terms of Service'). Where applicable under law, these Terms constitute a 'writing signed by you.'

### Changes to MyGeni.org and the Terms of Service

We reserve the right, at our sole discretion, to change, modify, add, or delete portions of these Terms of Service at any time without further notice. If we do this, we will post the changes to these Terms of Service on this page and we may send registered users an email notifying you of the change. **IF ANY MODIFICATION IS UNACCEPTABLE TO YOU, YOU MAY STOP USING THE MYGENI SERVICE. Mygeni's wish is linked to the Euro and there is a 1 to 1 ration which shall not fluctuate. MyGeni grants you permission to withdraw all or some



of your wishes accumulated in your account. This may be transferred into any bank account you so choose. You may also transfer Wishes to another persons account for goods or services acquired. MyGeni will not be held liable for any discrepancies within these accounts and these accounts do not accrue interest whatsoever. You may not use the MyGeni service to launder money of any nature and if MyGeni suspects you of doing so you will have your account frozen and all money confiscated by MyGeni and reported to your local authority.
